- 6. I shall not obstruct corridors and elevator lobbies prior to, during or after the term of the reservation.
- 7. I agree that special care will be taken with regard to the Mirrors that are present in the elevator. I agree that the Protective Pads must be in place prior, during and after and/or until the completion of the final inspection.
