Should any further security service be required, it will be charged at an additional \$25.00 + HST per hour.			
3. I shall notify the manager or superintendent and request an inspection of the elevator immediately prior to using the elevator. Upon completion of the move or delivery, I shall forthwith request a re-inspection of the elevator and affected common elements.			
4. I shall be liable for the full cost of all repairs to any damage, which may occur as a result of the use of the elevator by my agents or me. I shall accept the cost of repairs as assessed by the manager and acknowledge that all or part of the security deposit shall be withheld and applied towards the cost of repairs.			
5. I shall use the elevator during the term of the reservation.			
6. I shall take reasonable precautions to prevent unauthorized entry into the building during the term of the reservation.			
7. I shall not obstruct corridors and elevator lobbies prior to, during or after the term of the reservation.			
8. I agree that special care will be taken with regard to any MIRRORS that are present in the elevators. I agree that the PROTECTIVE PADS must be in place prior, during and after and/or until the completion of the final inspection.
