ELEVATOR RESERVATION AGREEMENT

This agreement is made herein between TSCC 1437 and the resident whose signature appears on this form. NO MOVES OR DELIVERIES ON SUNDAY, STATUTORY HOLIDAYS OR AFTER 6:00 P.M.

- 2. All moves/deliveries must be conducted through the MOVE IN ROOM using the service elevator.
- 3. It is strictly forbidden to use the other elevator for moving or deliveries.
- 4. Corridors are to be kept clear of items at all times.
- 5. The deposit is fully refundable subject to:
 - a) An inspection of the common elements for any damages, etc.
 - b) Use over the allotted time.

Failure to complete the move/delivery within the time limit stipulated in this agreement could jeopardize a portion or all of the deposit solely at the discretion of Management. When more than one move/delivery is booked for the same day, it is imperative that they start and finish at the appointed times.

In the event of damages incurred to the common elements, where said damages exceed that of the deposit, the Applicant whose name and signature shown on this agreement will be held liable for any additional costs to the Corporation.

The undersigned agrees to keep the "move in room" doors closed whenever they leave the area (either to go upstairs for more possessions or away with the moving vehicle, etc.). The security of the building MUST be safeguarded by the undersigned.
